2)**UNDER TEXAS STATE LAW(CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE) AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES.** Consequently, we will endeavor to care for your horses as we do our own but we are not responsible for any sickness and/or injury to your horses. If a problem arises, our first call will be to you, the owner, but failing to reach you forces us to treat any problem to your horses as we would our own. Any expense derived from said treatment is at the mare owner's expense. Your signature to this contract approves this stipulation and releases us to make the necessary decision concerning proper care.

3) The mare being boarded here will incur a \$10.00/day charge for personal feed and normal, daily care.

4) Your mare must be in obvious, good health and acceptable condition to breed.

5) Your mare MUST be manageable by us and tolerant of the procedures required to breed.

6) We are successful breeders knowing that if a mare does not settle it is generally (90% plus) the fault of the mare, i.e., infection, condition, age, etc. But we issue return privilege to rebreed this mare when accompanied by a Veterinarian's certificate stating she is clean of infection and capable of conceiving and carrying a foal. This mare can then be rescheduled to return to our farm for a second attempt. This privilege is only redeemable this breeding season unless a written release extends it to the following season. Those mares allowed to carry over until the following season, will be assessed a \$200 collection fee for the follow up breeding. Mares bred by us then later sold do not carry a live foal guarantee unless prior approval is issued by us. We will do all we know how to do to settle every mare brought to our farm.

7) All charges incurred in this breeding process are due and payable before the mare is released to depart this farm. No out-of-town checks without prior approval. Thank you for your patronage! We 'preciate ya!
